



**Premier Energy launches the auction process for procurement of electricity for the contractual period starting from April 1, 2021**

ÎCS „Premier Energy” SRL announces the launch of the auction process for the procurement of electricity, for the contractual period starting from **April 1, 2021**.

The auction will be conducted in accordance with the Electricity procurement procedure, Annex to the Electricity Market Rules , approved by [ANRE Decision no.283/2020 of August 7, 2020](#) (the Russian version of the document could be accessed [here](#)).

The program of the electricity procurement process provides for the following stages:

1. Notification of interested parties to submit applications for inclusion into the list of pre-qualified electricity suppliers;
2. Elaboration and publication of the list of pre-qualified suppliers admitted to the electricity procurement actions;
3. Publication of specifications and transmission of invitations to auction;
4. Receipt of offers, their evaluation and negotiations on the final price;
5. Notification of the results to the winners of the auction, attaching the contract for the sale-purchase of electricity;
6. Publication of the auction results, including the quantity contracted and the purchase price of electricity;

At the first stage, suppliers and producers are to submit their applications to be evaluated based on the established criteria and included into the list of pre-qualified electricity suppliers.

The criteria and documents required to be submitted by interested parties for inclusion into the list of pre-qualified suppliers are presented in [Annex no. 1](#) and [Annex no. 2](#).

The documents provided by potential suppliers and producers must be submitted in original or in copies authenticated by the signature of the administrator of the legal entity, or as notarized copies.

Suppliers and producers who have submitted duly completed applications and meet the qualification criteria will be included into the list of pre-qualified suppliers. In case of an incomplete application, the interested parties will be notified by e-mail about the missing information. The interested party has to submit the missing information or additional evidence for evaluation in order to complete the qualification process and to be included into the list of pre-qualified suppliers.

After the evaluation of the applications, based on the qualification criteria, ÎCS „Premier Energy” SRL will draft the list of pre-qualified suppliers and will notify the applicants of their inclusion. The list will be published on the company's website.



Potential suppliers and producers of electricity must submit the applications for qualification as a pre-qualified supplier, **by 15 February 2021**, by registered letter, in person or to the e-mail address [Reglementari\\_Furnizare@premierenergy.md](mailto:Reglementari_Furnizare@premierenergy.md).

The applications registered after February 15, 2021, will not be taken into account for the auction related to the contracting period starting from **April 1, 2021**. These applications will be evaluated to be included into the list of pre-qualified suppliers to be considered for participation in the subsequent auctions.
